Management Report

For Park updates, Ms. Murphy shared that a proposal will be submitted to VHB/Massworks for a \$ 2M parking lot reclamation/re-pavement project, to include pedestrian enhancements for safety. There will be an HVAC software upgrade through Siemens to improve efficiency and temperature control for each tenant. Additionally, there is an \$850K proposal for a second chiller to be installed by summer 2025, Siemens has submitted a financing package. Ms. Murphy also reported that Paul St. Pierre will be a new Board Member to fill the EOED seat on the Board.

Ms. Shinéad Laventure, Assistant Controller, Appleton Corporation, shared highlights of the Q1 financial statements for FY25, which were shared prior to the meeting. Of note, there was a \$413K net surplus for Q1.

Mr. Brendan Greeley, President, R.J. Greeley, Inc., shared highlights of the leasing activity report, including new prospects.

Mr. Russell Denver will remain a member of the Board through June 30, 2025.
