Mr. Brendan Greeley, President, R.J. Greeley, Inc., shared the leasing activity report prior to the meeting and reviewed updates during the management report. Ms. Shinéad Laventure, Assistant Controller, Appleton Corporation presented the Q2 financial statements during the meeting.

## **Call to Order**

Mr. Russell Denver called the meeting to order at 8:00 am and roll call was taken. A quorum was established.

## **Approval of Minutes**

A motion was made by Ms. Ellen Freyman to approve the December 12, 2023 meeting minutes. The motion was seconded by Mr. Daniel Keenan and approved unanimously via roll call.

## **Management Report**

Ms. Jennifer Murphy, Senior Property Manager, Springfield Technology Park, reported that there is not yet a confirmation of the Gubernatorial appointments to the Board of Directors, however she continues to work with a contact in the Governor's Western MA office. Ms. Murphy is exploring a weatherization and HVAC study to take advantage of Mass Save programs. The office occupancy at the Tech Park continues to be high, with Monday and Friday being lower occupancy days due to hybrid work models being the new normal among tenants.

Ms. Shinéad Laventure, Assistant Controller, Appleton Corporation presented the Q 2 financial statements, which are included in the packet. Ms. Laventure included information on current and projected cash and equivalents positions.

Mr. Brendan Greeley, President, R.J. Greeley, Inc., shared highlights from the leasing activity report.
